Government and foreign investors to discuss the business environment in Latvia and prospects for future development

On Thursday 7 June, a high-level meeting held in the Cabinet of Ministers will bring together representatives of the Latvian Government and Foreign Investors Council (FICIL) to discuss further improvements in the business environment that would promote Latvia's global competitiveness and encourage investment.

The high-level meeting will be held for already the 22nd time since the restoration of Latvia's independence, and the discussions will focus on labour supply, reforms in education, digitalisation of the economy, the fight against economic and financial crimes, as well as improvements in the investment environment and energy.

The foreign investors will be introduced to the latest trends in the national economy and main activities undertaken by the government over the last year in the fields of taxation, reducing the shadow economy, the development of e-government, the improvement of the business environment, reforms in education, as well as efforts to strengthen competitiveness of the economy.

"The Action Plan of the Government was approved more than two years ago. One of the key priorities set out in the Action Plan is the economic development of Latvia. This Plan needs to be continued. Latvia is not and will not be a low-cost labour country. We must be able to develop a knowledge-based, research-based economy," emphasizes Prime Minister Māris Kučinskis.

Therefore, one of the most important goals of the meeting is to achieve a shared vision of the future development of Latvia. An important aspect is the emergence of more and more well-paid jobs, so that people would not be motivated to abandon their countries in search of better life, but would rather consider the possibility of returning to their homeland and work in Latvia. In this context, it is important to focus on the transition from a labour-intensive economy to a knowledge-intensive economy, taking

advantage of the opportunities provided to Latvia by global trends.
